



CALL FOR NOMINATIONS FOR HPCSA 2019 PRESIDENTIAL HEALTH MERIT AWARDS – “PHMA”

The Health Professions Council of South Africa invites nominations from healthcare practitioners across all its health professions for the 2019 “Presidential Health Merit Awards”. These awards aim to acknowledge outstanding performance of individual practitioners. Nominations must be based on the following criteria –

1. Achievements across various areas of practice, which is aligned with Council’s vision of “quality and equitable healthcare for all”;
2. Fulfilling Council’s core values: transparency, rationality, accountability, consistency, impartiality, fairness, respect, dignity, honesty, integrity, effectivity, professionalism, responsiveness, efficiency, the principles of “Batho Pele”, and patriotism;
3. Provision of healthcare delivery, particularly in terms of enhancing access to healthcare for historically disadvantaged communities;
4. Dedication to quality healthcare, outstanding performance, dedication, community involvement, and going beyond the call of duty;
5. Their ambassadorial role in promoting healthcare;
6. Their commitment and compliance to the principles of the Patient Rights Charter;
7. Their contribution to sound professional behaviour and regulation;
8. Nominator and Nominee must be registered with the HPCSA.

An Awards Committee, appointed by Council’s Executive Committee, will evaluate all the nominations received. The decision of the Awards Committee is final, and no correspondence will be entered into.

12 practitioners will receive their awards at the official ceremony at the 1st HPCSA Conference scheduled for 19th August 2019.

The nomination must be motivated against these criteria and must be accompanied by a profile and colour photograph of the nominee. Entries should reach us by **Thursday, 25 July 2019**. No late entries will be considered. Supporting documents and/or media reports are welcome.

Shortlisted Nominees will be featured on the HPCSA Conference website and communication will be restricted to the Award-Winning Nominees.
